May cause slight skin irritation due to its alkaline nature, but does not require classification as an irritant. May cause slight eye irritation due to its alkaline nature, but does not require classification as an irritant. Observe precautions in section 8.2. Skin sensitization - although some plant extracts can be sensitizing to the skin, there is no evidence of sensitization caused by this product.
